- Certificate of Liability Insurance – Certificate Holder: Town of Johnstown
- Electrical or Plumbing? Provide copies of both Colorado Master and Contractor License
- \$100 fee – payable over the phone, mail in or drop off (Payable to the Town of Johnstown)
- Electrical Contractors are exempt from this fee
- Sole Proprietor? Complete Affidavit of Lawful Presence (Below)
- Not Sole Proprietor? Affidavit to Prove Lawful Presence not required
- Certificate of Good Standing from the Colorado Secretary of State's Office

AFFIDAVIT OF LAWFUL PRESENCE
