ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the **South Tank Water Line** will be received **from invited Bidders only**, by Town of Johnstown, at the Town of Johnstown Town Hall, (**450 S. Parish Ave, Johnstown CO 80534**) until **2:00 p.m.** local time on **September 30, 2021**, at which time the Bids received will be privately opened and read.

This project consists of furnishing and installing approximately 37,300 LF of 16-inch C905 (DR 18) PVC pipeline, 12" and 16" fittings, isolation valves, 2 air relief valves, 40 fire hydrants, pipe restraints, one HDD river crossing, four bored canal crossings, two tunneled railroad crossings, two county road crossings, and related work in conjunction with construction of the Town's new South Water Tank. Work is divided into two schedules. Schedule A includes all pipeline work not located in Colorado Boulevard. Schedule B reflects all work along Colorado Boulevard. Two PRV stations are also included as additive alternates.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis, with additive alternate bid items as indicated in the Bid Form.
